7. Derbyniwyd manylion Cynhadledd Flynyddol Un Llais Cymru – 5ed Tachwedd 2019 yn Pafiliwn Bont. Information was received with regards to One Voice Wales Annual Conference – 5th November 2019 at Bont Pavilion.
8. **Band Eang:** derbyniwyd gwybodaeth oddi wrth swyddfa Elin Jones AC yn ein hysbysu bod Llywodraeth Cymru wedi gosod cytundeb newydd i BT/Openreach i fynd ati i gyflwyno band eang yn Lot 1 (sy'n cynnwys Ceredigion). Gellir gweld os yw eich aneddle yn rhan o'r cynllun hwn trwy fynd i wefan Llywodraeth Cymru sef: gov.wales/go-superfast/what-are-my-options Ceir a'r ddeall hefyd bod rhai o drigolion Tynygraig yn ystyried cynllun cymorth y Llywodraeth ar gyfer derbyn y band eang "superfast". Maent ar hyn o bryd yn casglu enwau i weld faint yn union o

ddiddordeb fyddai i ymrwyo i'r cynllun. **Broadband:** information was received from Elin Jones' office informing us that Welsh Government had placed a new contract with BT/Openreach to place broadband within the Lot 1 area (which includes Ceredigion). At present they are collecting names to see how much interest there is.
