1. Sedd Wag: Mae'r Clerc wedi cysylltu efo'r Cyngor Sir am y sedd wag a rhaid hysbysebu'r sedd tan 20 Mawrth 2015. *Vacant Post: the Clerk has contacted the County Council with regards to the vacant post and we have to advertise until 20 March 2015.*
2. Biniau Grit / Grit Bins: Cytunodd y Clerc i wahodd Ian Williams y Cyngor Sir i un o gyfarfodydd y Cyngor Cymuned i drafod y sefyllfa Biniau Grit. *Clerk agreed to invite Ian Williams, County Council to one of the next meetings to discuss the Grit Bins situation.*
