

## CYNGOR CYMUNED YSTRAD MEURIG COMMUNITY COUNCIL

Cofnodion cyfarfod Nos Iau, 25 Ionawr 2018 yn Neuadd Eglwys Gwnnwss.. *Minutes of meeting held Thursday, 25 January 2018 at Gwnnwss Church Hall.*

Derbyniwyd cofnodion 2 Tachwedd 2017 fel rhai cywir. *The minutes of meeting held 2 November 2017 were received as a correct record.*

Ar gychwyn y cyfarfod croesawyd dau aelod o'r gymuned sef Bryn Howell-Pryce, Bwlchteulu a Mark Johnson, Brynmeherin i drafod y problemau band eang o fewn yr ardal. Eglurodd y Clerc iddynt y camau oedd wedi ei cymryd gan y Cyngor Cymuned a beth oedd y datblygiadau dros y flwyddyn newydd. Roedd cytundeb gwreiddiol Openreach efo Llywodraeth Cymru i estyn band eang drwy Gymru gyfan erbyn Rhagfyr 2017 wedi methu. O ganlyniad i hyn cafwyd ar ddeall bod llawer o'r gwaith paratoi wedi ei wneud, ond heb gysylltu pawb at y rhwydwaith. Cafwyd ar ddeall bod Julie James, Llywodraeth Cymru wedi cyhoeddi buddsoddiad pellach o £80miliwn i sicrhau bod y prosiect hyn yn cael blaenoriaeth, ac roedd ystyriaeth hefyd am ymestyn cytundeb Openreach yn y tymor byr. Cytunwyd felly mae'r ffordd ymlaen oedd cynnal cyfarfod cyhoeddus efo Elin Jones ac o bosib Ben Lake er mwyn i'r gymuned gael lleisio ei barn. Trefnwyd y cyfarfod hyn ar gyfer prynhawn Gwener, 9 Chwefror 2018 rhwng 4.30 a 6.00 yr hwyr yng Nghanolfan Edward Richard.

*Bryn Howell-Pryce, Bwlchteulu and Mark Johnson, Brynmeherin were welcomed to the meeting to discuss the broadband issues within the community. The Clerk clarified to them the steps that had already been taken with the Community Council and where the developments had reached over the New Year. The Openreach contract with Welsh Government which was to roll out broadband through Wales by December 2017 had failed. As a result, it was understood that a lot of the preparatory work had been completed, but the only remaining work was to actually connect the broadband. It is understood from Julie James, Welsh Government that a further investment of £80 million would be given to ensure that this project is given priority. There was also a consideration of extending Openreach's current contract in the short-term. It was therefore agreed to hold a public meeting with Elin Jones and possibly Ben Lake in order for members of the public to voice their concerns. The meeting was arranged for Friday 9 February 2018 between 4.30-6.00pm at the Edward Richard Centre.*

### Materion yn codi/Matters arising.

1. **40 Milltir yr Awr / 40 Miles per hour – Tynygraig:** Bu i'r Clerc fynychu cyfarfod Cyngor Cymuned Trawscoed lle mae cyflymder yn broblem hefyd. Roedd aelodau o'r cyhoedd am gyflwyno cais i gael arwydd 40mya o Fferm Dolgwybedin a thrwy bentref Tynygraig. Eglurwyd na fyddai hyn yn bosibl o dan matrics presennol y Cyngor Sir. Wedi trafodaeth cytunwyd i estyn gwahoddiad i Bwyllgor Priffyrrd y Cyngor Sir i gael pwylgor safle yn yr ardal i asesu'r union sefyllfa. O ran pentref Tynyragig cytunwyd i ysgrifennu ymhellach i'r Pwyllgor Craffu yn tynnu ei sylw am ein pryderon. *Clerk had attended a meeting of Trawscoed Community Council where speed limit is an issue as well. Members of the community were keen to have a speed limit from Dolgwynbedin Farm right through to Tynygraig. It was explained that this would not be possible as the current Council matrix does not cater for this. After a discussion it was decided to invite the Highways for a site meeting to discuss the situation. With regards to Tynygraig village it was agreed to write further to the Scrutiny Committee to raise our concerns that this urgently needs to be addressed.*
2. Adroddodd John Evans, Heddlu Dyfed Powys bod cyfres o ladrata a thorri mewn i eiddo wedi cymryd lle dros yr wythnosau diwethaf yn ardal Tregaron, un ohonynt yn ardal Ystrad Meurig. Nododd y dylai pawb gadw llygad ar ei aneddle a'r gymdogaeth leol. *John Evans, Dyfed Powys*
