Cofnodion cyfarfod Nos Iau, 28 Mehefin 2018 yn Canolfan Edward Richard *Minutes of meeting held Thursday, 28 June 2018 at the Edward Richard Centre.*

Yn bresennol / Present: Rhodri Davies, Thomas Jones, Siarl Owen, Sarah Jones, David M Jones a John Evans, Heddlu Dyfed Powys Police.

Derbyniwyd cofnodion 31 Mai 2018 fel rhai cywir. *The minutes of meeting held 31st May 2018 were received as a correct record.*

Materion yn codi/Matters arising.

1. **Gwefan** – gan nad oedd Technoleg Taliesin yn cyfathrebu efo ni, cytunwyd bod y Clerc yn rhoi un ymgais pellach i Nigel Callighan cyn mynd at i gael amcanbris oddi wrth gwmni arall. *Website- as Technoleg Taliesin were not communicating with us in relation to the website it was agreed that the Clerk should make one further attempt to Nigel Callighan before seeking estimates from other providers.*
2. **Sbwriel** – nid oedd sbwriel yr heolydd cefn wedi ei gasglu et oar 27/6 – dyma’r ail dro i hyn ddigwydd mewn cyfnod byr o amser. Roedd y Clerc wedi cysylltu efo’r Cyngor Sir yn syth, a’r ymateb a gafwyd oedd bod “problemau technegol”. *The rubbish on the back roads had not been collected on 27/6, this is the second time that this has happened within a short time. The Clerk had immediately contacted the County Council and the response received as that this was due to a “technical problem”.*
3. **Cyflwr Heolydd** – cytunodd y Clerc i gysylltu efo’r Cyngor Sir eto am y “culvert” yn Swyddffynnon a’r dwr sydd yn rhedeg i gefn tir y Siop, Swyddffynnon. *The Clerk agreed to write further to the County Council with regards to the “culvert” at Swyddffynnon and the water that collects to the rear of the Shop, Swyddffynnon.*

Gohebiaeth / Correspondence

1. Derbyniwyd llythyr yn diolch am ein rhodd o £50 oddi wrth Cylch MEethrin Pontrhydfendigaid. *A letter of thanks was received from Cylch Meithrin, Pontrhydfendigaid for our donation of £50.*
2. **CSC Pwyllgor Rheoli Datblygu** – derbyniwyd agenda a phapurau cyfarfod 9 Mai a 13 Mehefin 2018. *CCC Development Control Committee – agenda and papers for the meeting 9 May and 13 June 2018 were received.*
3. **Ysiwriant BHIB Insurance** – derbyniwyd cadarnhad bod ein ysiwriant wedi ei adnewyddu ar gost o £302.13. *Confirmation that our insurance had been renewed at a cost of £302.13 was received.*

5. **Defibrillator** – Derbyniwyd ebost gan Paul Westney ar ran Pwyllgor Canolfan Edward Richard yn gofyn i’r Cyngor Cymuned ad-leoli’r defibrillator a oedd y tu fewn i wal yr Eglwys i fan mwy gweladwy yn y pentref gan awgrymu y bocs ffôn. Wedi trafodaeth, cytunwyd mewn egwyddor, ond i geisio mwy o wybodaeth o ran lleoliad gweladwy gan nad yw’r blwch ffôn yn eiddo i’r Cyngor Cymuned, ac mae’n siwr gydag amser y bydd yn cael ei dynnu oddi yno gan nad oes defnydd iddo ar hyn o bryd. Cytunodd y Clerc i wneud ymholiadau pellach efo Mr Westney ac adrodd yn ôl i’r cyfarfod nesaf. *An email was received from Paul Westney on behalf of the Edward Richard Community Committee asking the Community Council to move the defibrillator which is currently located within the wall of the Church to a more visual place in the village, the suggestion of the*

telephone kiosk was made. Following a discussion in principal it was agreed, but, the view of the Council was to seek a more visual place for it rather than the telephone kiosk as this is likely to be removed in the near future due to not been used. Clerk agreed to make further enquiries with Mr Westney and report back to the next meeting.
