Materion y Codi / Matters Arising

Derbyniwyd llythyr oddi wrth Nest Jenkins yn diolch am ein rhodd o £50. A letter was received from Nest Jenkins thanking us for our donation of £50.

Gohebiaeth / Correspondence

1. Arwydd 40 milltir yr awr ger Dolfawr cais i leihau hyd y cyflymder. Ymatebwyd yn nodi dim gwrthwynebiad ond bod y cyngor cymuned yn siomedig i ddeall bod cost ynghlwm wrth wneud symudiadau o'r fath. *Change of 40 mph near to Dolfawr, Ystrad Meurig The Council replied with no objection but to note our concern with the cost associated with such a move.*
2. **CSC Precept 2016 – 2017** – cofnodir derbyn precept o £2682.43 oddi wrth y Cyngor Sir, wrth wneud asesiad o'r anghenion cyllidol, cytunwyd i barhau i ofyn am yr un swm o bresept a hynny yn bennaf at ddibenion o ran gwella cyfleuserau i'r trigolion yn ystod tywydd y gaeaf ac i sicrhau cyflenwad o finiau grit a grit i'w gosod ynddynt. *We have received a precept of £2682.43 from the County Council, when assessing our financial needs, it was agreed to ask for the same amount of precept purely towards improving conveniences to the residents during the winter months, ensuring that grit bins are located within the rural areas and a supply of grit.*
3. **CSC** – derbyniwyd gwybodaeth ynghylch gorchymyn parcio oddi ar y stryd. **CCC** – *information was received with regards to off street parking places.*
4. **CSC Cais Cynllunio A160351** newidiadau i Blaenyrorfa, Tynygraig – dim gwrthwynebiad. **CCC** *Planning Application A160351 changes at Blaenyrorfa, Tynygraig – no objection.*
5. **CSC Pwyllgor Rheoli Datblygu** 11 Mai 2016 – derbyniwyd agenda a phapurau'r pwyllgor. **CCC** *Development Control Committee – agenda and papers for the meeting 11 May 2016 were received.*
6. **Caeau Canmlwyddiant** – derbyniwyd gwybodaeth am y Caeau Canmlwyddiant yn gofyn am enwebiadau parciau i gofio'r Rhyfel Byd 1af. *Centenary Fields – information was received with regards to Centenary Fields asking for park nominations to remember the First World War.*
7. **Ysiwriant AON Insurance:** £331.90 – cytunwyd i dalu gan bawb oedd yn bresennol / *all present agree to pay.*
8. **Archwiliad Blynnyddol 2015-2016:** cadarnhaodd y Clerc bod y cyfrifon wedi ei archwyllo efo T Jones yn fewnol a D Morgan yn allanol, erbyn hyn mae'r archwiliad yn orffenedig ac yn barod i'w gyflwyno i'r Archwilwr allanol. Cadarnhawyd bod adrannau 1 a 2 yn orffenedig a'i bod yn cael ei cyflwyno i'r Archwilwr erbyn 6 Mehefin 2016. Roedd pawb a oedd yn bresennol yn gytun. *Annual Audit 2015-2016: the Clerk confirmed that the accounts had been audited internally by T Jones and externally by D Morgan and that the audit is now complete and ready to present to External Audit. It was confirmed that parts 1 and 2 were complete and to be presented for Audit by 6 June 2016. All present agreed.*
