Ar gychwyn y cyfarfod atgofodd y Clerc bawb o'r Côd Ymddygiad a'r pwysigrwydd o gydymffurfio ag ef. *At the beginning of the meeting the Clerk reminded all of the Code of Conduct and the importance of complying with it.*

Materion yn codi/Matters arising.

1. **Band Eang** –Bu cyfarfod pelalch yn Ystrad Meurig i'n cyflwyno i ddarparwyr annibynnol i BT a fyddai'n gallu cael band eang inni yn gyflym o dan gynllun sydd wedi ei noddi yn ariannol gan y Llywodraeth. Byddai angen adnabod clwstwr o anedde fyddai'n fodlon uno gyda'i gilydd i gael y gwasanaeth. Mater nawr i'r unigolion benderfynu os ydynt am fabwysiadu trefn o'r fath cyn bod gwasanaeth llawn BT yn cyrraedd yr ardal yn ol yr hyn a addawyd erbyn Rhagfyr 2017. **Broadband:** *a further meeting was held in Ystrad Meurig to introduce us to an independent company that would be able to provide us with broadband in the area. This scheme is funded by the Government, but we would have to identify a cluster of households who would be willing to work together to receive this service. This service is available at the individuals discretion prior to receiving the full BT service promised by the end of 2017.*
2. **Gwefan** – gan nad oedd Technoleg Taliesin yn cyfathrebu efo ni, cytunwyd bod y Clerc yn rhoi un ymgais pellach i Nigel Callighan cyn mynd at i gael amcanbris oddi wrth gwmni arall. **Website-** *as Technoleg Taliesin were not communicating with us in relation to the website it was agreed that the Clerk should make one further attempt to Nigel Callighan before seeking estimates from other providers.*
3. **Gwair y Parc** – cafwyd addewid gan y Cyng. D M Jones y byddai gwair y parc yn cael ei dorri yn fuan. *Councillor D. M. Jones promised that the grass in the park would be cut in the next few weeks.*
4. **Sbwriel:** Ar gais y Cyng. Rhodri Davies roedd y Clerc wedi cysylltu efo'r Cyngor Sir yn syth i nodi na fu i'r sbwriel gael ei gaslu yn yr ardal ar 23 Mai 2018. Yr ymateb a gafwyd o'r Cyngor Sir oedd bod yna broblem "dechnegol", a dim mwy! **Rubbish:** *At the request of Councillor Rhodri Davies the Clerk had contacted the County Council immediately to notify them of this. The response received was that there was a "technical" problem on 23 May 2018.*

Gohebiaeth / Correspondence

1. **HMRC:** Derbyniwyd hysbsiad bod newidiadau ar y gorwel i VAT126 claim. Information was received that changes were on the horizon to VAT126 claims.
2. **CSC:** Derbyniwyd taliad cyntaf ein praesept sef cyfanswm o £416.98, roedd costau etholaidol 2017 wedi ei dynnu o hwn, cyfanswm o £233,30. The first instalment of our precept was received, which was £416.98, £233.30 of election costs 2017 had been deducted from this first instalment.
3. **Archwiliad Blynnyddol 2017-2018:** cadarnhaodd y Clerc bod y cyfrfion wedi ei archwyllo efo T. Jones yn fewnol a D Morgan yn allanol, erbyn hyn mae'r archwiliad yn orffenedig ac yn barod i'w cyflwyno i'r Archwiliwyr allanol. Cadarnhawyd bod adrannau 1 a 2 yn orffenedig a'i bod yn cael ei cyflwyno i'r Archwiliwyr erbyn 18 Mehefin 2018. Roedd pawb a oedd yn bresennol yn gytun.
***Annual Audit 2017-2018:** Clerk confirmed that the accounts had been audited internally by T Jones and externally by D Morgan and that the audit is now complete and ready to present to External Audit. It was confirmed that parts 1 and 2 were complete and to be presented for Audit by 18 June 2018. All present agreed.*
4. **Un Llais Cymru:** Derbyniwyd agenda a phapurau'r cyfarfod 23 Mai 2018. ***One Voice Wales:** Agenda and papers for the 23 May 2018 meeting were received.*
5. Derbyniwyd holiadur Bwrdd Iechyd Prifysgol Hywel Dda parthed argymhellion i newidiadau sydd ar y gweill i'r gwasanaethau iechyd o fewn y GIG. Mae'r cyfnod ymgynghori yn agored tan 12 Gorffennaf 2018. *A questionnaire was received from Hywel Dda University Health Board with regards to proposals for changes to the health service in the local NHS. The consultation period is open until 12 July 2018.*
6. **Ysiwriant BHIB Insurance** – derbyniwyd pris adnewyddu ein ysiwriant, cyfanswm o £302.13 – cytunwyd gan bawb ein bod yn talu. *A renewal insurance quote was received, total of £302.13 – all agreed to pay.*
