## Minutes of meeting held on Thursday, 12 November 2020 at Gwnnws Church Hall

At the beginning of the meeting a minute silence was held to remember Councillor Dafydd Rhodri Davies, Pontargamddwr, Swyddffynnon who passed away on 7<sup>th</sup> September 2020. Sympathy was also extended to Councillors Thomas Jones and David M Jones on the passing of their sister Nancy Cook, Tynbwlich and also to Councillor Mair Humphreys, Penderlwyngoch on the passing of Miss Aeron Jones, Nantllan.

Minutes of the meeting held 27 February 2020 were accepted as a correct record.

Chair, Sara Jones welcomed all to the meeting and thanked all for their co-operation during a difficult and challenging year because of Covid-19. She noted that the Clerk and herself had communicated regularly during the year and in light of any urgent matters which needed attention it had been brought to the attention of the Councillors for consideration and approval where necessary.

Annual Meeting – the first part of the meeting was the AGM. The Clerk produced a short report on the year's events and presented the Annual Accounts 2019-2020 who had been audited internally by Councillor Tomos Jones and externally by Delyth M. Morgan. In light of the current situation it was agreed to re-appoint the officers for the current year.

The Clerk reminded all of the Code of Conduct and the importance of complying with it.

- 1. Annual Audit 2019-2020:** Clerk confirmed that the accounts had been audited internally by T Jones and externally by D Morgan and that the audit is now complete and ready to present to External Audit much later than expected due to the Covid-19 situation.. It was confirmed that parts 1 and 2 were complete and to be presented for Audit by Christmas. All present agreed.
- 2 Road Conditions:** The Clerk reported that she had sent a further request to the County Council with regards to the condition of the roads at Tŷ Nant, Penderlwyngoch, Rhiw Tynlon and Grid y Comin. To date we see that no maintenance work has been undertaken and therefore it was agreed that the Clerk would raise this further with the County Councillor Ifan Davies for further guidance. The Councillors noted their general concern with regards to the condition of the roads noting that better roads were receiving attention.
